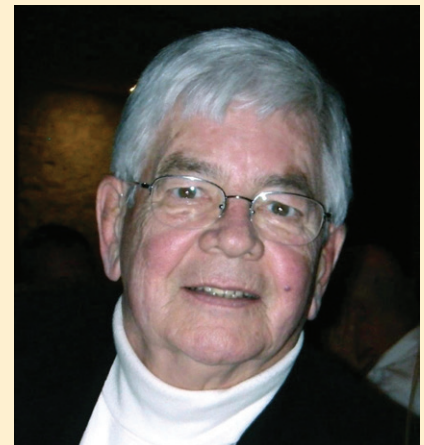

Snacks For Students

Snacks for Students began providing weekend snacks to eligible Pre-K through 4th grade students in March of 2012. The program is sponsored by the Rushville First United Methodist Church. Volunteers, including Rushville State Bank staff members, gather weekly to pack snack bags for distribution at the Schuyler-Industry School District. When In Doubt, Check It Out!!

Scammers are on the hunt for your personal information any way they can get it. They will send email or text messages with links to click, install malware on your computer or simply make a phone call. Using phone calls, attackers will use what is referred to as social engineering to take advantage of your emotions to access sensitive or confidential information. Callers may tell you about a large transaction posted to your checking account or debit card, they might claim you have computer problems, tell you a family member is in need of legal assistance or claim to be from a government agency like Social Security, the IRS or even Rushville State Bank. The requests will normally come with a sense of urgency in order to trick you into giving out information without thinking first.

- Before responding with any information, **take a moment** to think about “where” the communication is coming from: do not trust it blindly, including the phone number on the caller ID, the email address or the website domain. Your local bank; your credit card company; a government agency like Social Security **WILL NOT CALL YOU** for your personal information. They **WILL NOT** call for your online account user name or password, your account numbers, your debit card/credit card numbers, or your social security number. If you receive a call asking for

information like this; **HANG UP** and call the known/published number for the entity that was said to be calling. Do not call the number they give you.

- Before clicking a link in a text message or email; **THINK TWICE**. If you receive an unexpected request to reset a password for an online account – do not click the link before calling the known/published number for the account to confirm the request. **DO NOT** download files or open



documents from unknown sources – doing so may infect your computer or device with malware that will allow a scammer access to your personal information.

- Be aware of tech support scams – Microsoft does not reach out to consumers by email or telephone to inform them their computer requires an update. If you receive a message or pop-up on your computer asking you to click a link or call a number shown on the screen, **DO NOT DO IT**. Contact

a local tech support business or family member to assist with the computer issue if needed, but **DO NOT** pay any online tech support companies that contact you regarding your computer.

- Never give anyone your online banking account credentials, including your user name and password. **NO ONE** will ever call you to ask you for your access information to your banking, investment, or credit card accounts. Releasing this information will allow a scammer directly into your personal accounts, giving them the ability to transfer funds out of your account to the scammer. Rushville State Bank employees or their vendors **WILL NEVER** call, text or email you asking for your online banking username or password, your debit card, or account information.

If you believe you have been the victim of a social engineering attack over the phone, through email or text, or in person – contact Rushville State Bank at 217-322-3323 immediately for assistance in freezing your deposit accounts, credit and/or debit cards, and online accounts to prevent a potential loss of funds. Scammers work quickly once information has been released, so do not delay in contacting Rushville State Bank or other account holders in order to stop your information from being used against you. Do not be embarrassed if you think you have been a victim – your call will be handled confidentially and with respect.
